As per the maximum permissible CAMC charges after warranty period shall be 5% of the Total cost after excluding the items from Total cost for calculation of CAMC/AMC as given in Format A. The CAMC charges have to be quoted in INR (excluding GST) in Format B. Escalation of maximum 5% will be allowed after every three years of CAMC. The 'Cost of the equipment for CAMC/AMC calculation' shall not include additional warranty cost (if any), cost towards Installation, Commissioning and Testing (in addition to the original equipment cost of the OEM), cost of transportation including import customs duty in the case of fully finished imported goods quoted in INR, specific excluded items from CAMC/AMC as per the tender condition and also GST, if any, included in the Total cost. In respect of equipment quoted in foreign currency, the work orders for CAMC after warranty period will be issued by taking into account the exchange rate

As per the Institutes general policy, the maximum CAMC charges after warranty period will be 5% of the cost of the equipment. However the bidders can quote CAMC charges in the range of 3 to 10 % of the cost of equipment, depending on the nature of equipment to be maintained excluding the items from total cost for calculation of CAMC/AMC as given in Format A. The CAMC charges have to be quoted in INR (excluding GST) in Format B. Escalation of maximum 5% will be allowed after every three years of CAMC.
