The following Special Terms and Conditions (STC) will be applicable for the Automobile categories mentioned below for enlisting of products in GeM market and for procurement through Direct Procurement mode only. The STC would supersede the General Terms and Conditions (GTC) in respect of the conditions mentioned below for the below categories.

Automobile Categories

1. Ambulances - R
2. Automotive Chassis Fitted with Engine
3. Built Up Trucks (V2)
4. Buses
5. Cars (V2)
6. Troop Carrier Police Vehicles
7. Two Wheeler - Motorcycle, Scooter and Moped (V2)
8. Utility Vehicles (V2)
9. Water Truck Cabin Truck with Water Tank

Special Terms and Conditions

1. Only manufacturers of the vehicles are allowed to upload their vehicle models in above categories.
2. Manufacturers must give/ensure below mentioned minimum discount on the prevailing MRP across all locations while enlisting their products on GeM:

3. Presently, the portal does not provide for uploading of the same catalogue with different MRP for different locations. Therefore, net prices inclusive of discounts shall be indicated by manufacturers while offering their products on GeM. The seller may quote freight charges extra on per km basis or include freight charges in the total price offered for the catalogue. In both the cases, the seller will indicate applicable freight charges in the catalogue (zero in case freight is inclusive). The vehicle for Defence Buyer will be quoted separately with suffix "Defence" against each model.
4. In the scenario where the freight charges are quoted separately, the freight charges shall be calculated by the seller at the time of invoicing by multiplying distance with freight per KM indicated in contract specification. After supply of vehicles, the seller while submitting the invoice will indicate the freight amount at actuals subject to upper ceiling of freight charges as worked out by multiplying per KM freight charges with distance as mentioned above. The Contract will indicate the total amount inclusive of all taxes only without freight charges. Therefore, while blocking the amount, additional funds in the range of 2% to 14% shall be blocked over and above the total price inclusive of all taxes to cover the fund requirement for freight charges on approximate basis.
5. In the scenario where the freight charges are quoted as zero by the seller in the catalogue and price on the portal are inclusive of freight charges, the Contract will indicate the total amount inclusive of all taxes and freight charges. Therefore, while blocking the amount, buyer may select 0% as the additional funds to be blocked over and above the total price.
6. Seller can decline the order in case the freight charges payable by buyer are less than applicable and incident for this denial of order will not be raised by the buyer and will not be entertained by GeM. Therefore, buyer is advised to select appropriate percent of freight charges while blocking the funds. However, the payment of freight charges to the seller would be as per actuals and is not linked with percent of funds blocked in lieu of freight charges.
7. Delivery Period shall be 90 days. Delivery period for Built-up Vehicles like Ambulances, Troop Carriers, Water Tankers, Buses, and Built-up Trucks shall be 120 days considering extra time involved in fabrication. OEMs shall ensure that the prices offered on GeM by them for a particular model is the lowest and no supply shall be made to any Buyer, Government or Private, at a price lower or equal to that of GeM. In case of violation of this, GeM administration will review for removal of the model from GeM including other action as stipulated in General Terms and Conditions of GeM.
8. All manufacturers of Automobiles may upload their vehicles on GeM as per above guidelines. These guidelines are applicable only to GeM and Government Buyers shall utilize the portal for making on-line purchases through GeM.
9. Ceiling of direct buying as mentioned in GTC will not be applicable for vehicles under above Automobile categories. As such, buyers may go for Direct Purchase even beyond Rs. 25,000/- for

these categories. For any bulk purchases, a comparison of rates and discounts may be made for similar vehicles and bidding may be considered as the preferred option.

10. No Buyer other than Defence Buyer will select vehicle with suffix "Defence". In case Buyer does so, the responsibility for non-supply of vehicle rests with Buyer. Seller can decline the order in this scenario and incident for this denial of order will not be raised by the buyer and also will not be entertained by GeM.
11. No Government Buyer Central/State/PSU/Autonomous body/Academic Institute/Local Bodies etc. shall place any order at GeM prices outside GeM. Buyers shall note that prices on GeM are only applicable if the procurement is made through GeM portal. Using GeM prices for procurement outside GeM portal is strictly prohibited. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

4. Buyer Added Bid Specific ATC

Institute requirement is "25 seater Educational Institution Ac Bus" with following features / Specification

A: Vehicle Seating Capacity: - Since there is no change in the chassis for similar seating capacity, the requirement of seating capacity shall be made 25 seater AC Buses. Since there trip distance will be normally around 50 Kilometers, semi reclining type (2X2) is preferred.

B: Certification: -The vehicle shall conform to the requirement of the AIS : 063 for school bus and AIS: 052 for bus body and all other requirements as mentioned in Central Motor Vehicle Rules 1989 Rule 126, as amended upto date till the date of initial registration at Regional Transport Office Trivandrum.

C: Standards and Rules: -Dealer or manufacturer shall meet all the requirements of AIS:140 compliant instrument (AIS-140: Intelligent Transportation Systems (ITS) - Requirements for Public Transport Vehicle Operation) and as per the latest relevant standards issued by Motor Vehicles Department, Government of Kerala.

All buses of Type 1, II category shall be fitted with Fire Detection Alarm System (FDAS) and Type III category including Double Deck Buses and Sleeper Coaches shall be fitted with Fire Detection and Suppression System (FDSS) complying with AIS-135:2016, as amended from time to time.

D: Body Specification: - Fully Built bus with integral body is preferred. Shall comply with AIS: 052.

E: Warranty: -Warranty shall be clearly specified which shall not be less than 5years including extended warranty, if any, including spares. The Five years warranty sought for is OEM/bidder free warranty without any additional cost towards extended warranty to fulfil the tender condition. The charges, if any, claimed by the bidder towards warranty, Transportation cost, registration charges and agency commission, in this regard and included in the product cost should be mentioned in the price **format -A**, and upload the same in the prescribed place (Excel Upload - Financial Document Required). These charges shall not be considered for calculating actual CAMC value to be payable after warranty period. A certification in this regards stating whether the total cost quoted includes / does not include warranty charges, Transportation cost, registration charges and agency commission (if any) shall be furnished along with the Technical bid in **format - B**

F: CAMC:- The vehicle should be supported for another 10 years after warranty and extended warranty with comprehensive annual maintenance contract. Terms and conditions applicable to SCTIMST should be followed. As per the Institutes general policy, the maximum CAMC charges after warranty period will be 5%

of the cost of the vehicle and escalation in CAMC charges shall be allowed at maximum 5% of the previous year CAMC charges after every three years of CAMC. However bidder can quote CAMC as per the GeM condition of 3 to 10% of the cost of the vehicle.

G: Registration: -The vehicle shall be delivered through local dealers and get it registered in the name of Director, SCTIMST, Trivandrum at Regional Transport Office, Trivandrum

H: Dealership: The bidder shall be either a manufacturer or authorized dealer of vehicle manufactures having requisite prototype approval as mentioned in CMVR Rule 126.

I: Accessories: The dealer shall provide Kerala MVD vehicle location tracking device VLTD, Audio System, Reverse Camera and Dash Camera, CCTV etc. Any additional fitments/features provided shall be mentioned specifically.

J:Service: The Company shall have authorized service centre in Trivandrum District.

K: Turning Radius: shall be about 10 m for easier Manoeuvrability to enter in to the SCT main building campus.

R: Penalty clause:

1: Delay in Delivery:

If the supplier fails to deliver or install/commission any or all of the goods or fails to perform the services within the time frame(s) incorporated in the Purchase Order/bid document, the Purchaser shall, without prejudice to other rights and remedies available to the Purchaser under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, commissioning and/or services until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reached Purchaser may consider termination of the contract.

If any delay by the supplier in maintaining its contractual obligations towards delivery of goods and performance of services shall render the supplier liable to any or all of the following sanctions:

- (A): Imposition of liquidated damages,
- (B): Forfeiture of its Performance Security and
- (C): Termination of the Contract for default

2: Performance (during Warranty period)

Supplier should ensure uninterrupted service delivery of the vehicle during the warranty period. In this regard following conditions also may be noted:

(A): In case of any complaint to the vehicle, breakdown call has to be attended within 48 hours of intimation.

(B): The defect should be rectified within two days after the call is attended, failing which replacement or standby vehicle should be provided for uninterrupted services.

(C): In case of non-adherence to clause (I) or (II) above, downtime penalty will be realised a sum equivalent either the repairing charges met by the Institute to set right the vehicle or 0.5 percent per day of cost of the vehicle, whichever is higher, from the date of report of breakdown by way of deductions from SD/Performance Bank Guarantee.

(D): The time spent on the repair work will be added to the warranty period of the vehicle.

3: Performance (during CMC/AMC period)

Uptime means 95 percent of total days in a year during which the vehicle remains functional.

(A): Down time means any shortage in achieving the up-time
