Sub: Submission of Life Certificate - reg.

As per CCS (Pension) Rules, pensioners / family Pensioners are required to submit Life Certificate in November every year for further continuance of pension. All pensioners / family pensioners of SCTIMST are requested to submit their life certificate during the month of November 2022 itself.

2. All pensioners/family pensioners of the Institute are encouraged to use one of the following services to furnish "Life Certificate".

- a) Presenting themselves personally along with Pension Payment Order/Identity Card issued by the Institute.
- b) Submitting Life Certificate in the prescribed format duly attested by a Gazetted Officer. Format and A list of designated officials specified for signing Life Certificate is attached.
- c) Using the online facility of Digital Life Certificate (DLC) through Jeevan Pramaan Portal (https://www.jeevanpramaan.gov.in). Both Paying Authority and Disbursing Authority is to be selected as SCTIMST.
- d) Using the chargeable Doorstep DLC Service through India Post Payment Bank (IPPB) pensioners/family pensioners can request their nearest Post Office or make a request through "Postinfo App" or through the website <u>http://ccc.cept.gov.in/covid/request.aspx</u>. Both Paying Authority and Disbursing Authority is to be selected as SCTIMST.
- e) Using Doorstep Banking, through an Alliance comprising 12 Public Sector Banks, service request can be placed through "Doorstep Banking (DSB) app" / "<u>https://doorstepbanks.com</u>" / "<u>https://dsb.imfast.co.in/doorstep/login</u>" / Toll Free Number 18001213721, 18001037188.
- f) Using Face Authentication technology system based on UIDAI Aadhaar software for online submission on the Jeevan Pramaan mobile application. DoPPW's Pensioners Portal->Jeevan Pramaan->Process Flow.
- 3. Non-submission of life certificate may lead to discontinuance of pension.
