- 1. 1. Generic

Cost per reportable test will be paid by the Institute in subsequent months subject to conditions as per tender document.

The contract will be awarded initially for a period of five years extendable for further five years or more on the same terms & conditions, on mutual consent of both the parties and satisfactory performance of the successful bidder / its OEM. The Institute will, however, reserve the right to conduct performance review every year during the contract period and deficiencies / non complian ce reported, if any, noticed shall be required to be rectified by the successful bidder within a reasonable time fixed by the Institute. Furthermore the successful bidder has to submit a declaration in accordance with clause No.18 (annually) and this will also taken into account for the assessment of satisfactory performance. This Institute reserves the right to suo-motu terminate the contract without any notice at any point of time. The rate quoted will be frozen for entire contract period including extended period if any, without escalation. However, increase / decrease in GS T will be considered.

The equipment on offer should have the capability to perform following tests. The bidders are re quired to quote the aggregated value for the following number of tests to be performed during t he contract period on the GeM Portal. However, split up of quoted prices should be provided in P rice Format – A and uploaded in the prescribed place (Financial Document required) on online Ge M portal along with price bid only. The price quoted in the prescribed field on GeM portal will be considered for ranking purpose. Total price quoted in Price Format – A must match with the price quoted in GeM portal. The succ essful bidder should integrate their instruments in such a way that this facility can be provided uninterruptedly to the beneficiaries.		
7	The Institute will provide an air-conditioned environment, if necessary with uninterrupted power supply for the working of the system. However, the successful bidder has to provide compatible online UPS with 30 min. battery backup along with the equipment.

12	The successful bidder should keep an adequate buffer stock of the reagents and consumables et c required to conduct the test at SCTIMST and ensure that the testing procedures are not interru pted even in a shift due to the lack of reagents and other consumables. The Life period of any of the item supplied by the successful bidder will have the minimum of two third of the expiry period d remaining on the date of receipts of items in SCTIMST. The supplied items having less than two-third expiry period to SCTIMST shall not be accepted. Loss or premature deterioration due to b iological and/or other factors during life span of stores against the manufacture's standard warranty/expiry of such items shall be replaced by the contractor on free of cost basis.
13	The equipment, reagents and consumables, etc required to perform the test must have a valid I ndian product certification. In addition, a penalty of 2% of the cost incurred will also be e levied on each occasion. In the event, such occasions exceed more than three in a year; the In stitution reserves the right to terminate the contract.
18	If at any time during the period of contract, the price of cost per reportable test is reduced or bro ught down by any law or Act of the Central or State Government or by the bidder himself, below the contracted rate, their contracted rate will stand reduced automatically to the reduced level. Failure to provide reduced rate will be deemed as withdrawal from the tender and contract and s hall be dealt with accordingly. If supplies are made at higher rates after the reduction of rate, pa yments will be eligible at the reduced rates only.
19	Payment Clause
19.1	The bill in triplicate shall be provided to Department of Biochemistry, SCTIMST within first week of subsequent month. Monthly bill should be generated after calculating the number of reportable e tests for each line of items. The invoice should be accompanied by the list of successful / unsuccessful tests. No payment will be made for the unsuccessful tests due to any reason whatsoever. Further no payment will be made for goods rejected due to any reason whatsoever.
19.2	The bills should have full particulars of the numbers of each kind of test done during the invoice period.
19.3	The number of tests in the bill submitted should match with the records generated in the supplie d equipment.
19.4	No payment shall be made in advance at any circumstance whatsoever.

19.5	Bills for the month will be accepted only after ensuring supply of buffer stock of reagents, consu mables, etc for performing tests for the subsequent months. This is for the smooth running of the patient care services.
19.6	Payment will be made within 30 days of submission of invoice with relevant documents as menti oned in the tender document after making deductions for defaults, if any.
20	If at any time during the continuance of the contract, the performance in whole or in part by eith er party of any obligation under this Contract shall be prevented or delayed by the reasons of an y war, hostility, acts of the public enemy, epidemics, civil commotion, sabotage, fires, floods, ex plosion, quarantine restrictions, strikes, lockouts or act of God provided notice of happening of s uch event duly evidenced with documents is given by one party to the other within 10 days from the date of occurrence thereof, neither party shall be by reasons of such event, be entitled to te rminate the contract nor shall either party have any claim for damages against the other in resp ect of such non-performance or the delay in performance, and deliveries under the contract shall be resumed as soon as practicable after such event has come to an end or ceased to exist, and the decision of the Purchaser as to whether the deliveries have been so resumed or not, shall be final and conclusive, Provided further that if the performance in whole or part of any obligation u nder this contract is prevented or delayed by reason of any such event for a period exceeding 1 0 days, either party may at its option terminate the contract provided also that the purchaser sh all be at liberty to take over from the Seller at a price to be fixed by Purchaser, which shall be final, all unused, undamaged and accepted material, bought out components and stores in cours e of manufacture in the possession of the Seller at the time of such termination or such portion t hereof as the Purchaser may deem fit excepting such materials, bought out components and sto res as the Seller may with the concurrence of the Purchaser elect to retain.
21	In case of breach of any terms and conditions of this contract, the competent authority, will have the right to cancel the contract without assigning any reason thereof and nothing will be payable by SCTIMST and in that event the security deposit shall also stands forfeited.
22	If fails to fulfill any or all of the Services or delay in delivery within the original/re-fixed Delivery/T ime period(s) specified in the Contract, the Institute will be entitled to deduct/recover the Penalt y / Liquidated Damages for the delay from the security deposit/monthly bills, unless covered und er Force Majeure conditions aforesaid, @ 0.5% per week or part of the week of delayed period as pre-estimated damages not exceeding 10% of the contract value without any controversy/disput e of any sort whatsoever. Cumulative Penalty cannot exceed more than 10% of the total contract value after which the Institute shall have the right to get the service/rectification done from alter nate sources at the risk and cost of the service provider besides forfeiture of PBG. Seller shall be liable to reimburse the cost of such service/rectification to the Institute.
